Capacity Building in Africa

Hogan Lovells has been at the forefront of developing and supporting capacity building initiatives in Africa for many years. We have set out below a few highlights of our current and recent initiatives. We would be delighted to provide further details if required.

Working with African lawyers

As global leaders, we seek to share our knowledge and expertise by supporting our colleagues in private practice and the public sector with training and development.

Go far together

In 2017 we launched a tailored programme, ‘Go Far Together’ (GFT), working in collaboration with local partners to grow legal capacity in Africa. We believe that the support and development of the business as well as the pure legal skills of lawyers is critical and we invest vigorously in broad business training, including management, business development, finances and basic client administration.

Secondments and work experience

We offer secondments to our London office for lawyers from GFT firms that we work closely with, allowing them to spend up to three months with our teams and gain a better understanding of the international aspects of deals. We plan to extend this secondment programme to other Hogan Lovells offices.

The Africa Post-Graduate Work Experience Programme runs for two weeks every September. This unique programme started in 2015 and enables 5–6 African lawyers studying in the UK on post-graduate courses, to gain international experience in a City firm before returning home.

Some of the regular events we run are:

GFT Symposium:

Annual one day workshop with Senior Partners from our relationship firms, focusing on “The business of law” – held in London, enabling the participants to network with our clients at events organised the following day.

GFT discussions:

In 2020, in response to our desire to “remain present” on the continent despite restrictions on travel, we started an innovative programme of regular calls with our relationship firms from across Africa. These are now being restructured to provide a sustainable transfer of knowledge via bi-monthly sector-focused calls.

GFT sessions:

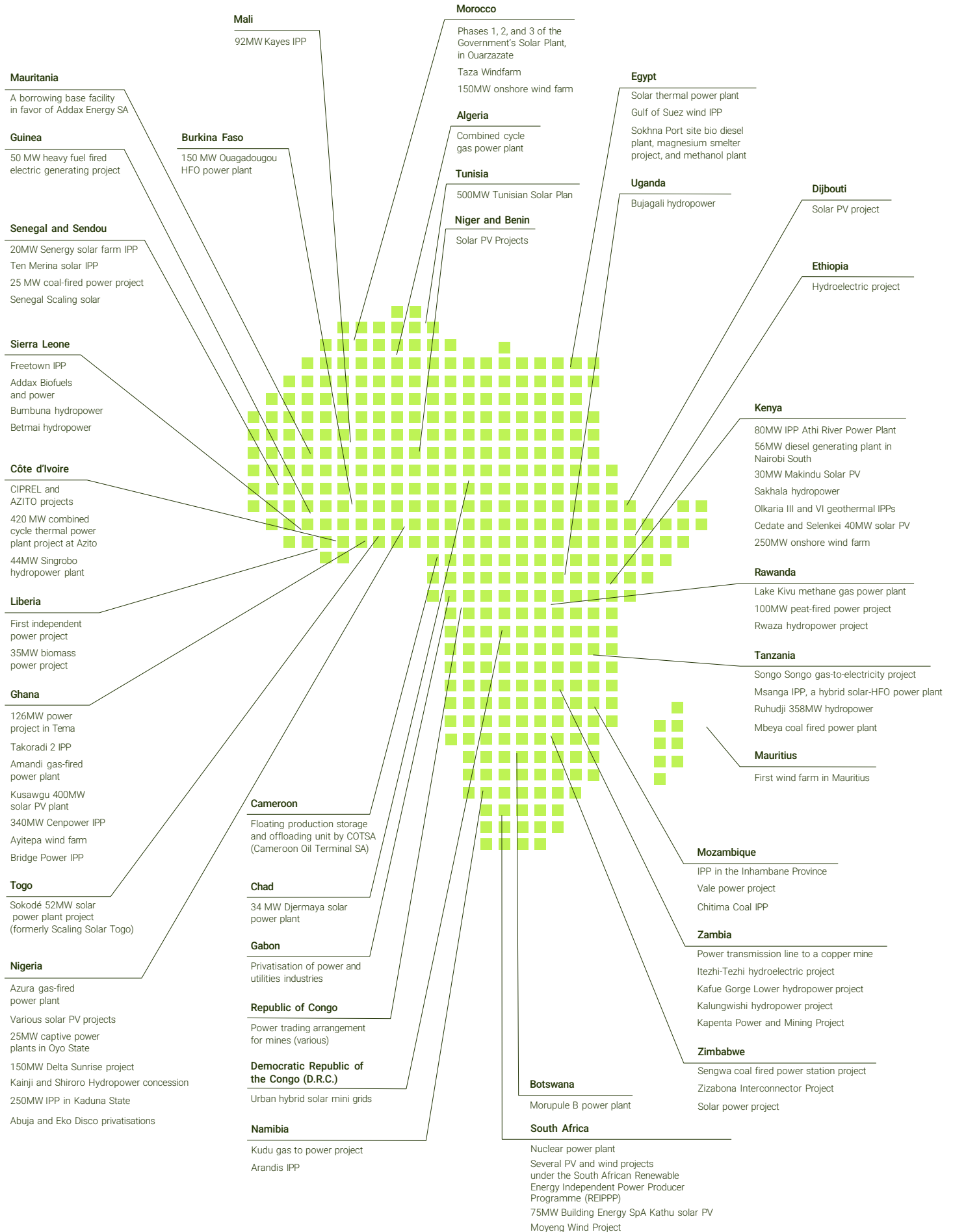
Following on from the success of the GFT Symposium, we extended this engagement to junior lawyers from our relationship firms, with sessions for associate/senior associates when in-country, and over Zoom in more recent years. These sessions focus on soft skills, personal and professional development training.

Training and networking:

We recently launched three online training modules to transfer knowledge in a more sustainable way, with access given to lawyers from any of our GFT firms. We are also establishing a network of African young professionals to connect, network, share ideas and experiences.

African Initiatives

Corporate Responsibility work forms a fundamental part of our core values. We have recently engaged in the following African initiatives:

International Senior Lawyers Project (ISLP): Economic restoration in Liberia has been crucial following the country's long civil war. 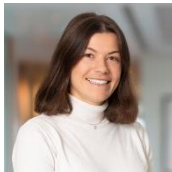

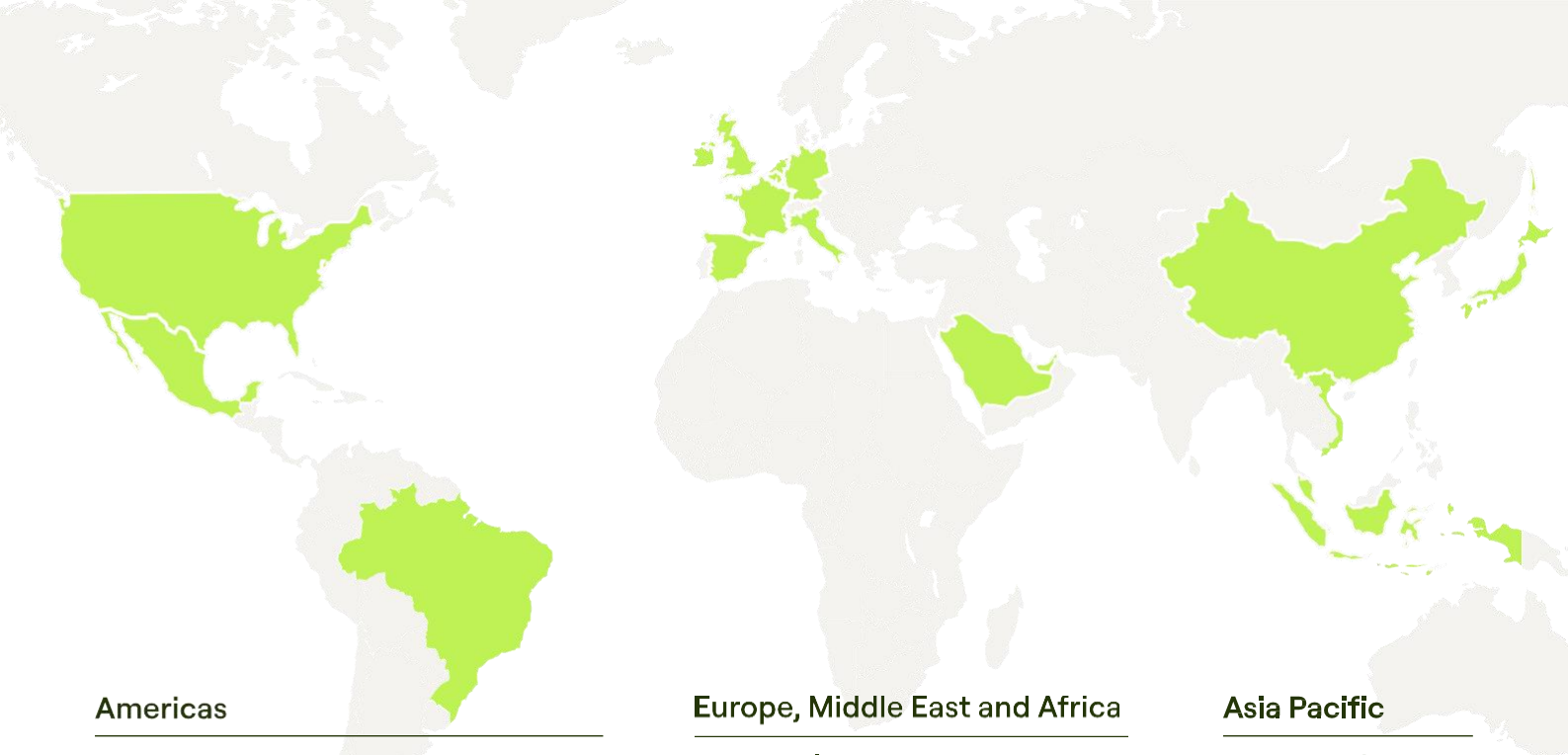
