

The NDAA's provisions are aimed at driving the Federal government's short- and long-term acquisition priorities and policies in the coming years. China updates technology catalogue for export control, targeting emerging and cutting-edge sectors

Late last year, China's Ministry of Commerce (MOCOM) and Ministry of Science and Technology published an updated catalogue of technologies whose export is prohibited or restricted ("Technology Catalogue"). This list, which is separate from China's export controls on dual-use goods, imposes controls on the export of various technologies. On December 22, 2023, President Biden signed the Foreign Extortion Prevention Act (FEPA) into law, revising Section 201 of Title 18 of the U.S. Code concerning bribery of government officials. This significant development bridges gaps in the 1977 FCPA, criminalizing both the payor and payee sides of foreign bribery activities — and expands liability to those acting on behalf of foreign government officials, even in an unofficial capacity. 
